TIME COMMITMENT: To be effective with the youth MUST commit to the entire

school year, at least 5 hours per week, some weekends,

evenings and non-traditional hours.

Position Description: The mentor serves as a caring adult in the youths' life and is available to listen, validate, and coach their mentee about navigating life and negotiating relationships as a young adult. Given the current conditions, as of now, this position will attend all SHIELD Mentor Program events virtually until further notice.

Primary Duties and Responsibilities:

- Co-develop mentorship plan with mentee which includes goals, actions activities can include exploring opportunities for learning, meeting educational, employment and communication engagement goals, defining needed resources etc.
- Work with matched youth in mentoring clusters in a virtual environment
- Encourage and support youth to set and meet educational, employment, and community engagement goals
- Complete program surveys, evaluations, and other relevant administrative tasks
- Work collaboratively, and in consultation with the Program Coordinator to best inform ongoing engagement with the mentee
- Participate in relevant professional development opportunities
- Virtually check-in with the Program Coordinator, as requested
- Attend on-going virtual trainings when needed or requested
- Document all engagements and interactions with the mentored youth by completing provided forms and submitting information to Program Coordinator
- Complete appropriate logs and forms provided
- Complete evaluation surveys as requested
- Recognize role as a mandated reporter and report any problematic issues



- Be patient and understand the mentoring relationship is a process that takes work and time
- Honor, all commitments made to the mentee and SHIELD Mentor Program
- MUST be available for the Awards Ceremony in late-April
- Attend Monthly online All Staff Meetings once a month
- May perform other duties as assigned

Qualifications:

- Be 18 years of age or older
- Have earned a high school diploma
- Be able to commit to spending at least one year in a relationship with a mentee in an ongoing, mentoring relationship
- Build the relationship by planning and participating in planned activities together engaged in a mutually agreed-upon mentoring activities with their mentee/s
- Serve as a positive role model by modeling desirable behaviors—e.g. patience, tolerance, and reflective listening
- Be comfortable and able to establish appropriate boundaries with the mentee and his or her family
- Be encouraging and supportive of the mentee
- Strive for mutual respect
- Build self-esteem and motivation
- Be willing to adhere to all program policies and procedures
- Be dependable and consistent in meeting the time commitments
- Be willing to communicate regularly, submit activity information, and take constructive feedback
- Not use illicit drugs
- Not use alcohol or controlled substances in an inappropriate manner
- Not be currently in treatment for substance abuse and have a non-addictive period of at least five years
- Not be currently in treatment for a mental disorder or hospitalized for such in the past three years

Application and Screening Process:

- Written application
- Copy of driver's license and proof of automobile insurance
- Criminal history check: state, child abuse and neglect registry, sexual offender registry



- Virtual interview
- Provide three personal references
- Attend two-hour virtual mentor training

Personal Characteristics:

- Behave Ethically: Understand ethical behavior and business practices, and ensure that your own behavior and the behavior of others is consistent with these standards and aligns with the values of the organization.
